



# PES Group Digest on the EU Response to the COVID-19 Pandemic

### List of European decisions

Date	Number of cases and deaths	European response
8 June	1 440 444 cases 168 898 deaths	The European Commission awarded nearly €166 million, via the European Innovation Council (EIC) Accelerator Pilot, to 36 companies set to combat the coronavirus pandemic and support recovery.
9 June	1 444 710 cases 169 207 deaths	Economic and finance ministers held a debate on the European Commission's proposal for a Recovery Plan.  EU ministers responsible for employment and social affairs had an exchange of views on how to make national employment and social policies more robust and labour markets more resilient to overcome the COVID-19 crisis.
10 June	1 449 988 cases 169 778 deaths	The European Commission assessed its steps and proposed a way forward for the fight against disinformation in the context of the COVID-19 pandemic.  The European Union adopted a €55 million support package for Syrian refugees and local communities in Jordan and Lebanon to mitigate coronavirus pandemic.

11 June	1 454 718 cases 170 294 deaths	Eurogroup ministers met to discuss the economic situation and recovery needs of the European Union Member States and the complementarity of national and European policies.  Eastern Partnership foreign affairs ministers met to discuss the future of this initiative and how to reinforce cooperation in light of the COVID-19 pandemic.
12 June		EU ministers responsible for health debated the legislative proposal put forward by the European Commission for a new, reinforced EU health programme EU4Health.  EU ministers responsible for internal market and industry will discuss the green and digital transitions as drivers of the European recovery and how to strengthen strategic EU value chains.

# The EU's response to the COVID-19 pandemic and the position of the PES Group

#### **European Parliament**

#### Economic Affairs

On 8 June, members of the European Parliament Committee on Economic and Monetary Affairs (ECON) had an exchange of views with Christine Lagarde, President of the European Central Bank, to discuss the latest monetary policy decisions of the ECB Governing Council. Christine Lagarde presented to MEPs the merits of the massive repurchase, through the Pandemic Emergency Purchase Programme (PEPP), of essentially public securities, as well as the recent extension of the scope and duration of this operation launched in mid-March in response to the COVID-19 pandemic. Lagarde assured MEPs that the ECB stands ready to do more to fulfil its mandate, which is not only to ensure price stability but also to support the EU's economic policies.

#### Regional Development

On 8 June, members of the Regional Development Committee (REGI) held a debate in the presence of European Commissioner for Cohesion and Reforms Elisa Ferreira on the 2021-2027 Multiannual Financial Framework (MFF) and on the impact of NextGenerationEU on Structural and Investment Funds. While welcoming the measures presented by the Commission to revive the European economy after COVID-19, MEPs were concerned about the budget cuts foreseen in the next MFF.

#### Conference on the Future of Europe

On 8 June, members of the Committee on Constitutional Affairs (AFCO) held a debate on the Conference on the Future of Europe and the role of the European Parliament. The launch of the Conference, foreseen originally to kick start in May, is now probably postponed to September, but the European institutions need to finalise an agreement on its scope and structure.

#### The Council of the European Union

#### Agriculture

EU ministers responsible for agriculture, who held an exchange of views by videoconference on 8 June, expressed a number of concerns about the impact that the "Farm to Fork" and "Biodiversity 2030" strategies could have on the Common Agricultural Policy (CAP). Almost all the delegations were particularly concerned about the very ambitious targets for reducing pesticide use and risks (-50%), the use of fertilisers and antibiotics (-50%), and the area returned to nature (10%).

Moreover, EU ministers welcomed the European Commission's recent proposal for the revised 2021-2027 MFF, which provides for an increase of €26.5 billion in current prices to the agricultural budget compared to the draft presented in 2018. However, the vast majority of the delegations also felt that this increase in the agricultural envelope is still insufficient in view of the additional efforts that will be required of farmers under the *Green Deal*.

#### Economy

On 9 June, economy and finance ministers had a first exchange of views on the EU Recovery Fund, ahead of the European Council on June 19. Ministers addressed the basic structure of the new EU recovery instrument, namely its overall size, the nature and allocation criteria of the funds and the governance framework.

On the same day, the Organisation for Economic Cooperation and Development (OECD) announced that Spain, France and Italy will be the countries hardest hit this year by the coronavirus. According to the OECD, the COVID-19 pandemic has triggered the most severe recession in nearly a century.

#### The Eurogroup

On 11 June, the finance ministers of the euro area held a video conference to discuss the needs for the recovery plan and the European Commission's proposal, on the table of next week's European Council. Ministers also discussed the implications for the Euro area and a possible Eurozone dimension for the recovery facility to protect the single currency. Another key issue of the meeting was the need to coordinate recovery plans at the national level. As Eurogroup Chair and Portuguese Minister Mario Centeno said: "Coordination is key to ensure that we avoid divergence and the build-up of our imbalances"

The next Eurogroup in July will be the last meeting chaired by Centeno, following his recent announcement to resign from the government by mid-July. His decision opens the race to the position of Eurogroup Chair, for which, according to the media, Nadia Calviño (PES), Spain's Deputy Prime Minister with a focus on economic affairs, and Pierre Gramegna (RENEW), Luxembourg's Finance Minister, have expressed an interest. In Portugal, Centeno will be replaced by State Secretary for Budget João Leão.

#### The European Committee of the Regions

On 8 June, members of the Commission for Environment (ENVE) of the European Committee of the Regions held a debate with Virginius Sinkevičius, European Commissioner for Environment, Oceans and Fisheries, on the reviewed 2020 Work Programme and on the Green Recovery Plan.

Opening the debate, the Chair of the ENVE Commission, PES Group member and Mayor of Seville, Juan Espadas, said: "The European Green Deal is our roadmap for the economic and social recovery, which has to be also a green recovery. The European Union institutions can count on regions and cities to play an active role, as we can suggest strategies to better support societies and those most affected. To leave this crisis behind, we need to focus our efforts on building the world of tomorrow together at all levels, and I thank in particular Commissioner Sinkevičius for his dialogue with us today and his openness to intensify our cooperation."

The meeting also included debates on five opinions, among which the one by PES Group member Birgit Honé, Minister for Federal and European Affairs and Regional Development (Lower Saxony, Germany) on clean hydrogen. Moreover, members appointed Enrico Rossi, PES Group Vice-President and President of the Tuscany Region,



as rapporteur of an upcoming opinion on the "Renovation Wave", the EU's initiative to upgrade the energy performance of Europe's building stock.

On 15 June, the "Green Deal Working Group" of the European Committee of the Regions will hold its first meeting in the presence of Aurore Lalucq (S&D, France), Chair of the European Parliament's Intergroup on the Green New Deal, and Diederik Samson, Head of Cabinet to European Commission Executive Vice-President Frans Timmermans.

#### The European progressive family

This week, the S&D Group, in a letter addressed to the European Commission, put forward its position on the shape of the future Pact on Migration and Asylum, which the European Commission is expected to adopt at the end of June.

#### The fight against fake news

On Wednesday 10 June, European Commission Vice-President Věra Jourová and High Representative Josep Borrell published a Joint Communication, which analyses the immediate response to fight disinformation in the context of the COVID-19 pandemic and proposes concrete action to counter disinformation propaganda. To counter propaganda attempts by foreign actors, the Commission wants to strengthen its own communication efforts within and outside the EU.

On 9 June, the European Commission launched the 11<sup>th</sup> *Access City* Award competition. The competition is intended to reward a city's efforts to promote accessibility for people with disabilities. Due to the COVID-19 pandemic, the contest will pay particular attention to the accessibility of public services in times of pandemic, explained socialist European Commissioner for Equality, Helena Dalli. Cities with more than 50,000 inhabitants are invited to apply until 9 September 2020. The first, second and third place winners will be awarded prizes of 150,000 euros, 120,000 euros and 80,000 euros respectively.
